Message from the Board

The Rotary of Business

Most of us come into the world of Rotary through our vocations and people we know through our vocations. Rotary is a service organization with deep vocational roots. Paul Harris started Rotary in 1905 with a few of his vocational associates, and to this day our business classifications exemplify the close relationship between our vocations and service.

Just what is the relationship between Rotary and our vocations? The 2nd Object of Rotary obliges Rotarians to “encourage and foster high ethical standards in business and professions, recognize the worthiness of all useful professions, and dignify each Rotarian’s occupation as an opportunity to serve society.”

In 1989 the Rotary International Council on Legislation provided more specific guidelines for the “high ethical standards” referred to in the 2nd Object of Rotary...

“As a Rotarian engaged in a business or profession, I am expected to:

- Consider my vocation to be another opportunity to serve;*
- Be faithful to the letter and spirit of the ethical codes of my vocation, to the laws of my country, and to the moral standards of my community;*
- Do all in my power to dignify my vocation and to promote the highest ethical standards in my chosen profession;*

- *Be fair to my employer, employees, associates, competitors, the public, and all those with whom I have a business or professional relationship;*
- *Recognize the honor and respect due to all occupations which are useful to society;*
- *Offer my vocational talents: to provide opportunities for young people, to work for the relief of the special needs of others, and to improve the quality of life in my community;*
- *Adhere to honesty in my advertising and in all representations to the public concerning my business or profession;*
- *Neither seek from nor grant to a fellow Rotarian a privilege or advantage not normally accorded to others in a business or professional relationship."*

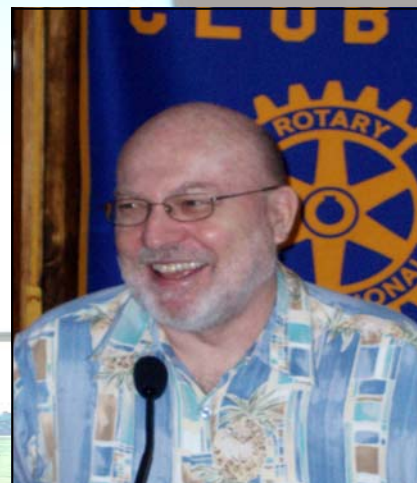

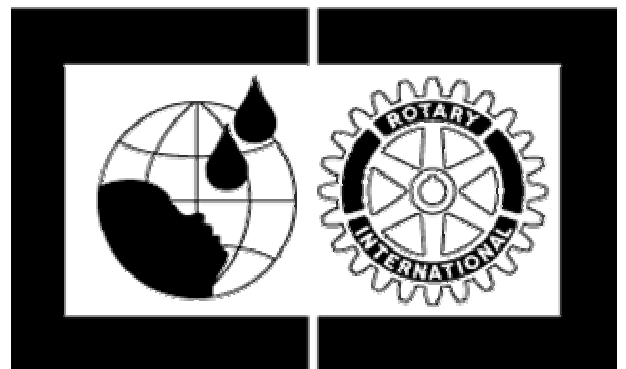

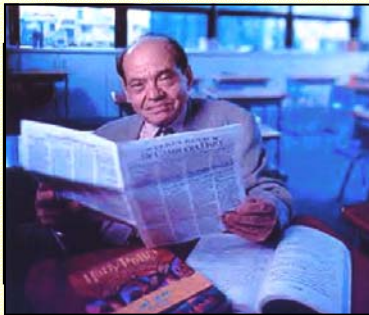
