HAIL TO THE CHIEF!

In spite of the newsletter arriving in your mailbox a little late, a crowd of sixty gathered at Waialae Country Club to hear **HPD Chief Susan Ballard**, pictured at left, speak at our first general membership meeting of the year. Read below for coverage of her presentation.

HONOLULU CHIEF OF POLICE A STAND-OUT

Honolulu Chief of Police, Susan Ballard, likes to start her presentation by asking her audience what issues most concern them. As always with an airline group, no one was shy and hands went up quickly. Many topics came up and I will mention some briefly. However, the main idea I would like to convey is that we have a police chief who is well educated, well-trained and competent, with a no-nonsense approach to the job. She is exactly what we all want in a chief, and more.

Most of us do not personally know the character or personalities of those who are in contention for any office, let alone that of Chief of the Honolulu Police Department. When Susan Ballard became the chief on November 1st of 2017, she was probably the person most of us were hoping would get the nod because we were impressed that a woman could do so well among a group of officers in which some members still gave the impression they were part of "the ol' boys club". The "more" that she brings to the position is personality plus.

Ballard was both entertaining and informative as she walked the room, answering questions. At the right she listens to a person who was hit from behind by a drunk driver and felt the case had not been handled well. Ballard told her she should have contacted the Professional Standards Office (808-723-3775) or the Police Commission (808-723-7580). (Your report must be made within 60 days.)

Many of us wanted to know what Ballard thought of the bill, currently under consideration by the legislature, on the legalization of marijuana for recreational use. (Hawaii allows it for medical use only.) Legaliza-



tion of marijuana is just one more headache for the police department as, unlike inebriated drivers, it is nearly impossible to prove a driver in an accident was impaired by the use of marijuana. In both Colorado and Washington, the accident rate has increased since marijuana use was legalized in those states. (Statistics are not in for states who have legalized cannabis more recently.) More children have had to be treated at ERs because of accidental ingestion. The drug is known to be harmful to young people. Ballard said the majority of those who speak in favor of marijuana at hearings are people who have money in the game. Indeed, I googled the status of the bill in the Hawaii legislature and of the 12 items that came up on the first page, only one was an impartial report. All the others were posted by promoters of legalization.

Ballard also mentioned that the police department is understaffed. There are openings for police officers and civilians. The civilian jobs are in the Personnel, Financial, Communication, Dispatcher and Radio Shop departments. If you know of anyone who might qualify for positions in these departments, suggest they contact the HPD.

These are just a couple of the major topics that came up during Ballard's presentation. Her "right hand", Officer Nancy DeFoster, let her know time was running out and they had another appointment. We were sorry to see them go, especially because Ballard managed to find humor in the humorless situations with which the police have to deal. She is an exceptional speaker.

Ballard did say that we could support the police officers by writing to our legislators regarding bills such as the one on marijuana. I wonder how she feels about SB 557, which is now under consideration, which would make Honolulu a sanctuary city? It is known as a law that interferes with the police doing their job in some cases. As I say, time ran out. I think all who attended the meeting would appreciate having HPD Chief Susan Ballard speak to us again.


